

ORDINANCE NO. 23-O-3

**ANNUAL TAX LEVY ORDINANCE FOR PLEASANTVIEW FIRE PROTECTION DISTRICT
AN ORDINANCE FOR THE LEVY, ASSESSMENT AND COLLECTION OF TAXES FOR THE PLEASANTVIEW FIRE
PROTECTION DISTRICT, COUNTIES OF COOK AND DUPAGE, ILLINOIS.**

**BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE PLEASANTVIEW FIRE PROTECTION DISTRICT, COOK
AND DU PAGE COUNTIES, ILLINOIS;**

The amount of taxes for the present current and future new fiscal year, for all corporate purposes, inclusive of the sums, if any, necessary to retire general corporate bonds and bonded indebtedness of the Pleasantview Fire Protection District, and interest thereon and the interest upon unmatured bonds to be levied on all property of the Pleasantview Fire Protection District, including railroads, as the same are assessed and equalized for State and County purposes, are hereby fixed at Thirteen Million, Five Hundred Fifty-One Thousand Four Hundred Ninety-Four and 00/100 Dollars (\$13,551,494) and the same is levied upon all property in the Pleasantview Fire Protection District, Cook and DuPage Counties, Illinois, subject to taxation.

Thirteen Million, Five Hundred Fifty-One Thousand Four Hundred Ninety-Four and 00/100 Dollars (\$13,551,494) being taxes to be levied as described in Sections I, II and III of the Ordinance shall, when received, be used for the purpose of paying those items for each of which an appropriation has been, or will be made in the Combined Annual Budget and Appropriations Ordinance passed by the President and Board of Trustees of the Pleasantview Fire Protection District on the 12th day of December, 2023, and published by order of the Secretary of the Pleasantview Fire Protection District, Cook and DuPage Counties, Illinois, on the 20th day of December, 2023, in the DuPage County Chronicle and the Cook County Chronicle, secular newspapers of general circulation, that have been regularly published and circulated in the District for more than six months prior to the date of publication of the Ordinance, as required by law, as will more fully appear from the certificate endorsed upon the original Ordinance now on file in the office of the Secretary of the Pleasantview Fire Protection District, and as will be duly appropriated by reason of the change of this fiscal year.

SECTION I - GENERAL CORPORATE FUND

The following sums, or so much thereof as may be authorized by law, have been or will be appropriated for the Corporate Purposes of the Pleasantview Fire Protection District, Cook and DuPage Counties, Illinois.
