I.M.R.F. FUND

I.M.R.F. Fund Levy \$ 10,000.00

The foregoing amount is hereby levied for Illinois Municipal Retirement Fund contribution and withholding purposes under and pursuant to 40 ILCS 5/7-171.

WORKMEN'S COMPENSATION FUND

Workmen's Compensation Fund Levy \$ 450,000.00

The foregoing amount is hereby levied for Workmen's Compensation Fund contribution and withholding purposes under and pursuant to 40 ILCS 5/7-171.




